When you apply to the Vicar's Relief Fund, you are required at the point of application to upload evidence of the cost/s you are applying for.


Please see below the list of evidence you are required to provide for the relevant items/costs under the different grant categories and what formats we can accept. **We cannot assess your application without this evidence**.

Where we ask for a letter or email as evidence, <u>please ensure the letterhead/all email header information</u>, including the sender's name, email or <u>street address</u>, date, time and other relevant information is included. For verification purposes, we cannot accept text copied and pasted into a Word or .pdf document, or SMS/text/WhatsApp messages.

Category: Accessing Accommodation (up to £500)
